CLARIFICATION

Consequent upon issuance of revised rates of TA-DA and other allied provisions related to official touring of personnel vide order no. ED(HR&A)/MPPGCL/Estt/3480-81 dtd. 25/07/2013, the following queries have been raised by some of the disbursing offices. The matter is, therefore, clarified as under :-

	<u>Query</u>	<u>Clarification</u>
(1)	The extent of admissibility/charges in respect of officers for stay in MP Tourism(MPSTDC) hotels may please be intimated, if MP Tourism hotel charges are more than maximum limit prescribed for the category.	The provision for stay & reimbursement of accommodation charges at M.P. Tourism (MPSTDC) Hotels within the State as made applicable vide e/w MPSEB's order no. 01-01/IV/1953/382 dtd. 19/05/2009 for MPPGCL's personnel under Category-A (under clause-1) of order no. 3480 dtd. 25/07/2013 shall continue as per bills raised by MP Tourism (MPSTDC) Hotel, but limited upto accommodation charges of single occupancy A.C. room only. However, due to discontinued facility of non-A.C. accommodation at MP Tourism hotels, personnel falling under Category-B & below, shall be reimbursed accommodation charges as per their eligibility & revised monetary ceiling only as mentioned under Clause-5 of MPPGCL's order no. 3480 dtd. 25/07/2013.
(2)	Whether permission of Hon'ble M.D. is still required to officers for Air travel, if otherwise eligible as per their category.	The necessity of obtaining prior permission from Hon'ble M.D. for Air travel as per CMD, MPPGCL letter no. CMD/MPPGCL/ 131 dtd. 17/02/2009 still continues.
