The GoMP Finance Deptt. Memo No.F-9-2/2010/Rule/4 dtd.08/11/2012 regarding revision in commutation value of pension is hereby adopted in mutatis mutandis for the employees/officers of erstwhile MPSEB, finally transferred and absorbed in MPPGCL.

Accordingly, for the purpose of pension commutation, the rates i.e. commutation value for the pension of Rupee 1/- per annum has been revised w.e.f. 01/08/2012 as per table given here under:-

Further, GoMP Notification No.F-12-14/2009/Rule/4 dated 05.02.2013 alongwith the Order No.F-12-14/2009/Rule/4 dated 03.04.2013 have been also adopted w.e.f. 05.02.2013 for the employees/officers of erstwhile MPSEB, finally transferred and absorbed in MPPGCL as per following :-

- (i) A Pensioner who has commuted a portion of his pension will have his commuted portion of pension restored from the first day of the following month after 15 years from the date of commutation.
- (ii) For the purpose of commutation, the meaning of "Pension" shall be "Basic Pension" and not the "consolidated pension" i.e. first pension fixed or revised pension re-fixed due to revision of pay applicable on the date of retirement. No commutation shall be allowed on the revised pension if revision is due to any other reason.
