## ORDER

Consequent upon the revision of TA/DA rates by the GoMP, vide Finance Department Memo No. F 11-12/2010/ Niyam/ Four Dated 05/09/2012, MPPGCL is pleased to adopt mutatis mutandis the provisions, except Clause No. 2 of aforesaid memo and with modified Clause No. 1 – “Categorization of Personnel” ( कार्मिकों का वर्गीकरण ) as contained here in this order.

The above mentioned provisions are applicable for the personnel of erstwhile MPSEB finally transferred and absorbed in MPPGCL, personnel working on deputation in this company and contractual officers/ employees of equivalent cadre.

The rates of TA/DA and applicable provisions are as under :-

- (1) **Categorization of personnel** : The personnel are categorized in 5 categories according to grade pay in pay band as under :-

- (2) **Daily Allowance** :- The daily allowance is revised by integrating Daily allowance, Head Quarter Allowance and Special Halt Allowance into one “ Daily Allowance” (D.A.) as hereunder:-

However, the concerned officer's own certificate regarding non-availability of accommodation in MPPGCL/ e/w MPSEB successor company's Guest House and MP Tourism Hotels shall be submitted with claims.
